As a communications specialist, Justin's primary responsibilities include covering events in the Latin America and the Caribbean (LAC) region, shooting video and taking photographs, and writing, editing and publishing articles and mission news.

Jordan's primary responsibilities include growing the English-as-a-Second-Language program in Belize, working with short-term mission teams, providing consistent communication updates regarding the mission work being done, and building leadership and seminar training in Belize.

Justin's hometown is Loveland, Colo., where Immanuel Lutheran Church and School (ILCS), the church he attends, is located. Over the years, he has helped in the ministry of this congregation, leading the high school youth program, working with the technology team and serving in music ministry. Justin received his B.A. in Journalism from Colorado State University, Fort Collins, and his A.A.S. in Computer Networking from Front Range Community College, Fort Collins. Prior to serving in Belize, he worked as a voice actor and a technology contract worker for Intersys. In April 2019, Justin and Jordan helped build houses in the Dominican Republic with Habitat for Humanity. Justin enjoys anything Star Wars, watching movies, reading, video games and playing softball.

Jordan's hometown is Cedaredge, Colo., and she also is a member of ILCS. She serves as this church's business manager. Jordan attended the University of Northern Colorado, Greeley, and received her A.A. in Liberal Arts from Aims Community College, Greeley. Before serving in Belize, she worked as a small business team lead for an insurance agency and as a personal banker/teller. Over the years, Jordan has tutored refugees and students in conversational English. She also helped at a Belizean children's home in Dec. 2017. Jordan enjoys anything outdoors (hiking, running, long walks), reading, watching movies, drinking coffee and making fresh smoothies.
